- Return completed form together with **FOUR photographs (two taken from each side, measuring 6" x 4")** of the machine, taken side-on UNFAIRED with a **large (9" x 6") stamped addressed envelope** (remember you will need to add more stamps for large envelopes) and a **cheque** crossed and made payable to C.R.M.C. Ltd. for the sum of £20.00 (£40.00 non members) per machine to:-
